15 Defendant HENRY FRANCIS SEAMAN, having been duly  
16 served with a Summons and Complaint in the above-entitled matter  
17 on the 25th day of June, 1987, and having failed to answer or  
18 otherwise appear and defend as required by law, and the Clerk of  
19 this Court having entered a default in accordance with Rule 55(a)  
20 of the Nevada Rules of Civil Procedure, this Court finds all the  
21 allegations in the complaint to be true, and the plaintiff  
22 thereby is entitled to the relief prayed for in the complaint;

23 THEREFORE, IT IS ORDERED, ADJUDGED AND DECREED as  
24 follows:

26 1. That Defendant shall pay the sum of \$150.00 per  
27 month per child for a total of \$300.00 per month, as and for the  
28 support of his two minor children, REBECCA RENEE SEAMAN, born

1 October 24, 1979, and SARAH MICHELLE SEAMAN, born April 23, 1982.  
2 The first \$300.00 payment shall be due upon entry of this order,  
3 and subsequent monthly payments shall be due on the same day of  
4 each month thereafter until said minor children are emancipated  
5 or until further order of this Court.  
6

7 2. That plaintiff shall have and recover judgment in  
8 the amount of \$4,925.00, which sum represents child support  
9 arrearages outstanding for the period commencing January 15, 1985  
10 to September, 1986.

11 3. That Defendant shall pay the sum of \$30.00 per  
12 month toward the \$4,925.00 arrearages above stated, said \$30.00  
13 arrearage payment to be combined with the \$300.00 ongoing child  
14 support payment, for a single monthly payment of \$330.00.  
15

16 4. That said monthly payments shall be made by  
17 defendant in either in the form of a cashier's check, certified  
18 check, or money order or in cash. If the payment is in the form  
19 of cash, it must be delivered to the Douglas County Clerk at her  
20 office in Minden, Nevada. If the payment is in the form of a  
21 cashier's check, certified check, or money order, it must be made  
22 payable to the DOUGLAS COUNTY CLERK and be either mailed to the  
23 Douglas County Clerk at Post Office Box 218, Minden, Nevada  
24 89423, or delivered to said County Clerk at her office in Minden,  
25 Nevada. The Douglas County Clerk shall transmit said payments to  
26 COURT TRUSTEE, P.O. Box 3544, Terminal Annex, Los Angeles,
