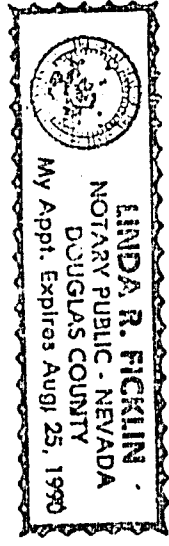


EXHIBIT A
