DEED OF TRUST WITH ASSIGNMENT OF RENTS

THIS DEED OF TRUST, made this 24th day of October, 1987, between

PAUL MELVIN KNOLL and JOAN L. KNOLL, husband and wife herein called TRUSTOR,

WESTERN TITLE COMPANY, INC., a Nevada Corporation herein called TRUSTEE, and

NORWIN DARL VOSS and MARJORIE E. VOSS, husband and wife as joint tenants herein called BENEFICIARY,  
WITNESSETH: That Trustor grants to Trustee in trust, with power of sale, that property in THE COUNTY OF DOUGLAS, STATE OF NEVADA, viz:

LOT 24, as shown on the Revised Plat of LAKERIDGE ESTATES NO. 1, filed for record in the office of the County Recorder of Douglas County, State of Nevada, on February 23, 1959, as Document No. 14083.

TOGETHER WITH the right to use the existing roadway over the Northwesterly 7.5 feet of lot 25 and over the Northeasterly 20 feet of lot 23 both as shown on the revised plat of Lakeridge Estates No. 1.

Together with the tenements, hereditaments and appurtenances thereunto belonging or appertaining, and the reversion and reversions, remainder and remainders, rents, issues and profits thereof, subject, however, to the right of Beneficiary, during any period of default hereunder, and without waiver of such default, to collect said rents, issues and profits by any lawful means, and to apply the same, less costs and expenses of collection, to any indebtedness secured hereby.

For the purpose of securing (1) payment of the sum of \$ 30,000.00----- with interest thereon according to the terms of a promissory note or notes of even date herewith made by Trustor, payable to order of Beneficiary, and all extensions or renewals thereof; and (2) the performance of each agreement of Trustor incorporated herein by reference or contained herein; (3) payment of additional sums and interest thereon which may hereafter be loaned to Trustor, or to his successors or assigns, when evidenced by a promissory note or notes reciting that they are secured by this Deed of Trust.

To protect the security of this Deed of Trust, Trustor agrees: By the execution and delivery of this Deed of Trust and the note secured hereby, that provisions (1) to (16) inclusive of the Deed of Trust recorded in the Book and at the page, or document No. of Official Records in the Office of the county recorder of the county where said property is located, noted below opposite the name of such county, viz.:

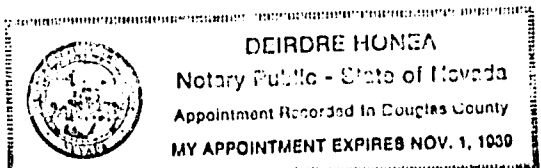
