3. You have the right to revoke or terminate this durable power of attorney at any time.



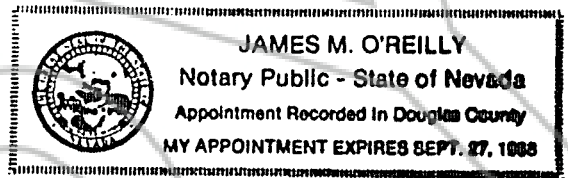
