16 A stipulation by and between the parties having been  
17 filed with this Court in relation to the above-entitled matter,  
18 the court having reviewed said stipulation and all other  
19 pleadings and documents on file with the clerk of this Court, the  
20 parties having agreed to the entry of this order and judgment by  
21 their stipulation, and good cause appearing;  
22

23 This Court finds, concludes, and orders as follows:

24 FINDINGS OF FACT

25  
26 1. Defendant is the father of MARTIN CHRISTOPHER  
27 SOLGAT, born December 25, 1970.

1           2. Defendant's support obligation for MARTIN  
2 CHRISTOPEHR SOLGAT, born December 25, 1970, is \$100.00 per month  
3 until said minor child reaches the age of 18 years, marries or is  
4 sooner self-supporting, pursuant to a decree of divorce on file  
5 in King County, Washington, dated September 27, 1972.

6  
7           3. Child support arrears for defendant's minor child  
8 MARTIN CHRISTOPHER SOLGAT accrued during the period June, 1972,  
9 through December 1986, in the amount of \$2,700.00.

10           4. Defendant's child support obligation during the  
11 period January, 1987, through November, 1987, computed at the  
12 rate of \$100.00 per month, is \$1,100.00, for his minor child  
13 MARTIN CHRISTOPHER SOLGAT, born December 25, 1970.

14  
15           5. During the period January, 1987, through November,  
16 1987, defendant paid the sum of \$2,270.00, as child support for  
17 his minor child MARTIN CHRISTOPHER SOLGAT, born December 25,  
18 1970.

19           6. Defendant is in arrears in his child support  
20 obligation in the sum of \$1,530.00, computed as follows:  
21 Arrearages of \$2,700.00 through December, 1986, plus \$1,100.00  
22 owed as child support during the period January through November,  
23 1987, equals \$3,800.00, minus \$2,270.00 paid by defendant in  
24 1987, for a child support arrearage sum of \$1,530.00, through  
25 November, 1987.

1           7. Defendant agrees to pay \$300.00 on December 5,  
2 1987, \$100.00 to be applied as ongoing support, and \$200.00 to be  
3 applied as payment on child support arrears.  
4

5           8. Defendant understands that an income or wage  
6 withholding may be sought by the plaintiff if the defendant  
7 becomes thirty days or more delinquent in making his child  
8 support payments.

9           9. Every finding of fact hereinabove which is held  
10 upon review to be a conclusion of law is hereby adopted as such.  
11

12                           CONCLUSIONS OF LAW

13           1. This Court has jurisdiction of the subject matter  
14 and the defendant.  
15

16           2. Defendant owes a duty of support to his minor  
17 child MARTIN CHRISTOPHER SOLGAT, born December 25, 1970.

18           3. Every conclusion of law hereinabove which upon  
19 review is held to be a finding of fact is hereby adopted as such.  
20

21                           ORDER AND JUDGMENT


22           1. Defendant shall pay \$100.00 per month for the  
23 support of his minor child MARTIN CHRISTOPHER SOLGAT, born  
24 December 25, 1970. The initial payment shall be due on December  
25 5, 1987, and subsequent payments shall be due on the 5th day of  
26 each month thereafter until the minor child emancipates or  
27 further order of the court.

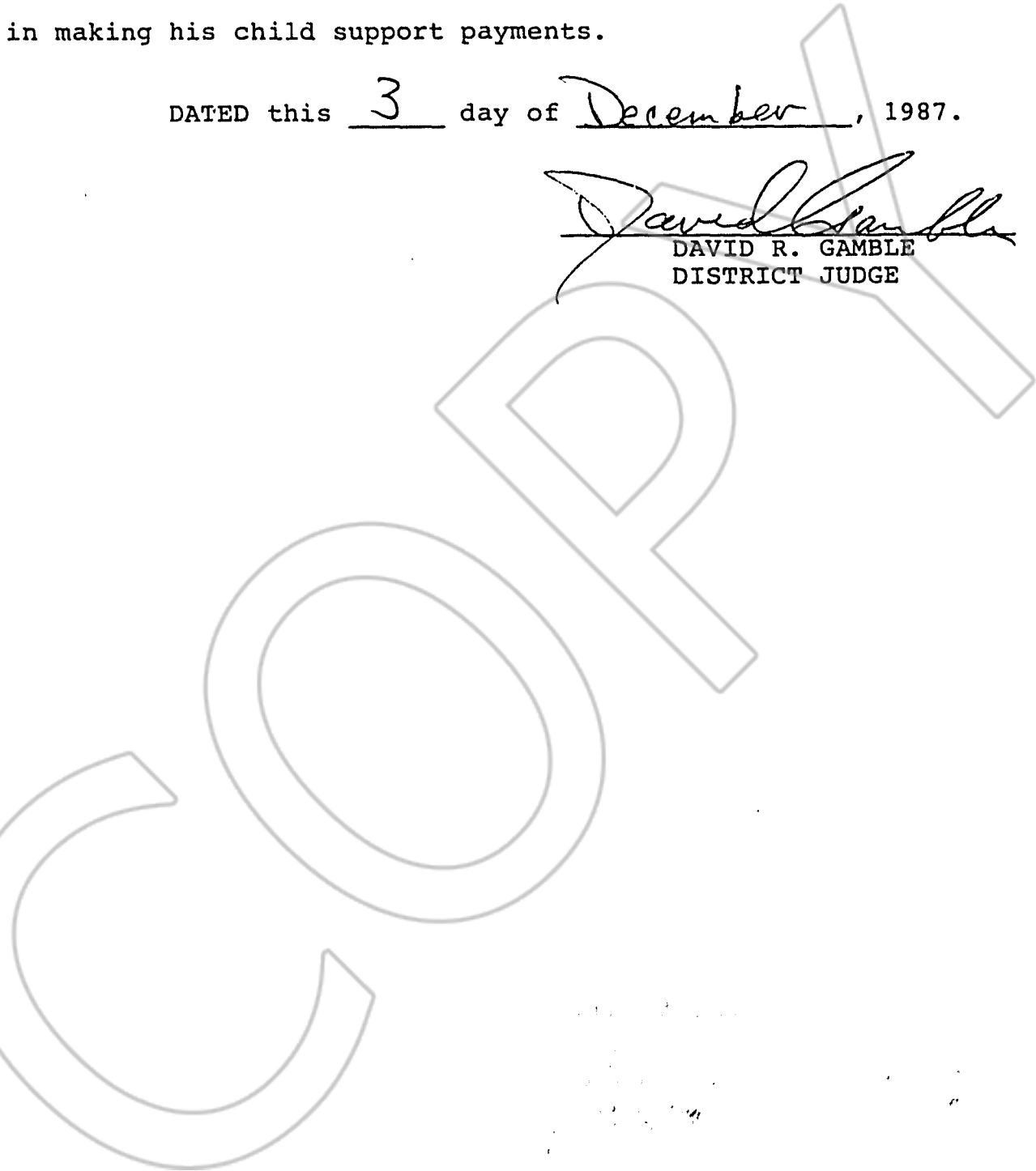
