WHEREAS, the undersigned are the present beneficiaries under said deed of trust; and



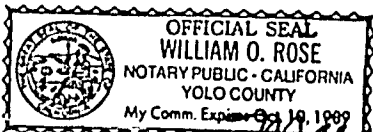

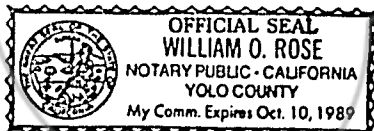
