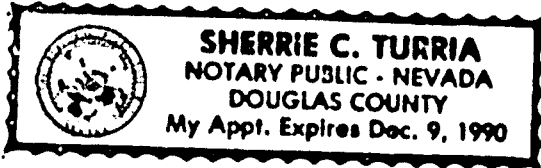

LEGAL DESCRIPTION

A Parcel of land in the Northeast Quarter of the Northeast Quarter of Section 9, Township 12 North, Range 19 East, M.D.B.&M., Douglas County, Nevada, particularly described as follows:

Commencing at the Northeast Corner of said Section 9, thence South $00^{\circ}09'00''$ West, 648.56 feet, and North $89^{\circ}39'30''$ West, 350.29 feet, to the True Point of Beginning, which is the Northeast corner of the Parcel; thence South $0^{\circ}09'$ West, 340.00 feet to the Southeast Corner of the Parcel; thence North $89^{\circ}39'30''$ West 324.88 feet to the Southwest Corner of the Parcel; thence North $0^{\circ}09'$ East 290.00 feet, to the Northwest corner of the Parcel; thence South $89^{\circ}29'30''$ East 6.17 feet to a point; thence North $45^{\circ}20'30''$ East 70.71 feet, to a point; thence South $89^{\circ}39'30''$ East 268.71 feet, to the True Point of Beginning.

Together with a non-exclusive right of way for roadway purposes, 15.0 feet in width lying North of the Northwesterly of the following described line;

Beginning at a point from which the section corner common to Sections 3,4,9 and 10, Township 12 North, Range 19 East M.D.B. &M., bears South $00^{\circ}09'00''$ West a distance of 648.56 feet; thence North $89^{\circ}39'00''$ West a distance of 589.00 feet, to the Westerly termination of said Right of Way.
