DEED OF RECONVEYANCE

KNOW ALL MEN BY THESE PRESENTS:

WHEREAS, BANK OF THE WEST the Beneficiary and holder of the Deed of Trust made, executed and delivered on DECEMBER 27 19 85, by RAY H. COLLISHAW AND EARLYN B. 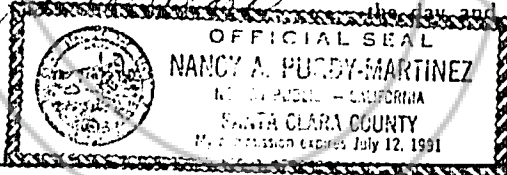
