POWER OF ATTORNEY

KNOW ALL MEN BY THESE PRESENTS:

That I, WILLIAM JAMES NUNN, of Douglas County, Nevada, do hereby appoint, make, and constitute LEATRICE MAE NUNN, of Douglas County, Nevada, to be my true and lawful attorney-in-fact for me and in my name and on my behalf to receive and receipt for any and all sums of money or payments due or to become due to me, to deposit in my name in any bank or banks any and all monies collected or received by her; to pay any and all bills, accounts, claims, and demands now or hereafter payable to me; to draw checks or drafts upon any and all bank accounts or deposits belonging to me; to act for me in any business in which I am now or have been engaged or interested; and generally to do and perform all matters and things, transact all writings, assurances, and instruments which may be requisite or proper to effectuate any manner or thing appertaining or belonging to me and generally to act for me in all matters affecting my business or property, real or personal, which I now own or hereafter acquire, with the same force and effect to all intents and purposes as though I were personally present and acting for myself, hereby ratifying and confirming whatsoever my said attorney shall do by authority hereof.

In the event of the death of LEATRICE MAE NUNN, during my

lifetime, or, in the event she should for any reason be unable or unwilling to serve, or fail to qualify or cease to act as my attorney-in-fact, I nominate NANCY LEE NUNN to be my attorney-in-fact.

This power of attorney shall not be affected by subsequent incapacity of the principal.




