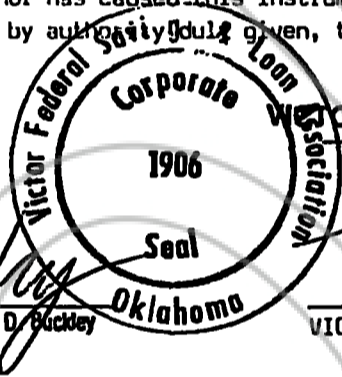
1. The Promissory Note (herein called the "Note"), evidencing the indebtedness secured by the Mortgage or Deed or Trust or Security Deed.
