AND DEED OF TRUST AND ASSIGNMENT OF RENTS



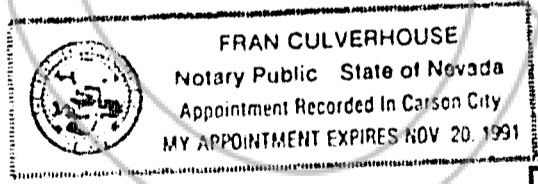
