A stipulation by and between the parties having been filed with this Court in relation to the above-entitled matter, the court having reviewed said stipulation and all other pleadings and documents on file with the clerk of this Court, the parties having agreed to the entry of this order and judgment by their stipulation, and good cause appearing;

This Court finds, concludes, and orders as follows:

## FINDINGS OF FACT

1. Defendant is the father of AMBER LYNNE ALLIGER, born July 6, 1978.

- 2. The Superior Court of the State of California,
  County of Orange, entered an order on or about May 1, 1984,
  requiring defendant to pay child support for his minor child
  AMBER LYNN ALLIGER in the sum of \$100.00 per month, commencing
  May 1, 1984, and continuing thereafter until said dependent
  reaches majority, becomes emancipated or until further order of
  the Court.
- 3. Child support arrears for the sum of \$2,048.00, owing for minor child AMBER LYNN ALLIGER, have accrued during the period October 1984 through March 21, 1988,
- 4. Every finding of fact hereinabove which is held upon review to be a conclusion of law is hereby adopted as such.

## CONCLUSIONS OF LAW

- 1. This Court has jurisdiction of the subject matter and the defendant.
- 2. Defendant owes a duty of support to his minor child AMBER LYNNE ALLIGER, born July 6, 1978.
- 3. The \$2,048.00 arrearage described in finding of fact number 3 is a lawful arrearage. This conclusion is made evident by NRS 130.280.
- 4. Every conclusion of law hereinabove which upon review is held to be a finding of fact is hereby adopted as such.

ORDER AND JUDGMENT


- 1. Judgment and order shall be entered in favor of the plaintiff for the sum of \$2,048.00, which sum represents child support arrearages owing.
- 2. Defendant shall pay \$50.00 per month as payment on child support arrears. The initial payment on child support arrears shall be \$48.00, and shall be due on April 20, 1988, and subsequent payments on child support arrears shall be \$50.00, and shall continue to be due on the 20th day of each month thereafter until the child support arrears are paid in full or further order of this Court.
- 3. Defendant shall pay \$100.00 per month as ongoing child support for his minor child AMBER LYNN ALLIGER, born July 5, 1978. The initial payment shall be due on April 20, 1988, and subsequent payments shall continue to be due on the 20th day of each month thereafter until the minor child has become emancipated or further order of this Court.
- 4. All child support payments and payments on child support arrears, for the combined monthly sum of \$150.00, to be made by defendant to plaintiff, must be in the form of a cashier's check, certified check, or money order, or in cash. If the payment is in the form of cash it must be delivered to the Douglas County Clerk at her office in Minden, Nevada. If the payment is in the form of a cashier's check, certified check, or money order, it must be made payable to the DOUGLAS COUNTY CLERK

and be either mailed to the Douglas County Clerk at Post Office Box 218, Minden, Nevada 89423, or delivered to said County Clerk at her office in Minden, Nevada. The Douglas County Clerk shall transmit said payments to the PROBATION OFFICER, County of Riverside, Case No. D71162, P.O. Box 833, Riverside, California 92502-0833.

5. An income or wage withholding may be sought by the plaintiff if the defendant becomes thirty days or more delinquent in making his child support payments.
