## Excerpts From Internal Revenue Code

Sec. 6321. Lien For Taxes.

If any person liable to pay any tax neglects or refuses to pay the same after demand, the amount (including any interest, additional amount, addition to tax, or essessable penalty, together with any costs that may accrue in addition therato) shall be a lian in layor of the United States upon all property and rights to properly, whether real or personal, belonging to such person.

Sec. 6322. Period Of Lien.

Unless another date is specifically fixed by law, the Beri imposed by section 6321 shall arise at the time the assessment is made and shall continue until the liability for the amount so assessed (or a judgement against the texpayer existing out of such liability) is satisfied or becomes unenforceable by reason of lapse of time.

## Sec. 6323. Validity and Priority Against Certain Persons.

(a) Purchaser's Holders Of Security Interests, Machanic's Lienors, And Judgement I for Crnditors. - The lien imposed by section 6321 shall ert he valld as against any purchaser, holder of a security notice thereof which meets the requirements lies creditor until notice thereof which meets the requirements of subsection (f) has been filed by the Secretary.

(B) Personal Property - In the case of personal property, whether tangible or intangible, at the residence of the taxpayer at the time the notice of lien is ified.

For purposes of paragraph (3) (8), the residence of a corporation or partnership shall be deemed to be the place of which the principal executive office of the business is located, and the patholphi associates of the preparate is located, and the sestidence of a tarpayer whose residence is without the United States shall be deemed to be in the District of Columbia.

Sec. 6325. Release Of Lien Or Discharge 10 Property

(a) Release Of Lien. - Subject to such regulations as the Secretary may prescribe, the Secretary shall issue a certificate of release of any lien imposed with respect to any internal revenue tax not later than 30 days after the day on which .

(1) Liability Satistied or Unenforceable - The Secretary finds that the liability for the amount assessed, together with all nierest in respect thereof, has been fully satisfied or has

become legally upenforceable; or

(2) Bond Accepted - There is furnished to the Secretary and accepted by him a bond that is conditioned upon the payment of the amount assessed, together with all interest in thereof, within the time prescribed by law (including any extension of such time), and that is in accordance with such requirements relating to terms, conditions, and form of the bond and sureties thereon, as may be specified by such regulations.

Sec. 6103. Confidentiality and Disclosure of Returns and Return Information.
