16 A stipulation by and between the parties having been
17 filed with this Court in relation to the above-entitled matter,
18 the court having reviewed said stipulation and all other
19 pleadings and documents on file with the clerk of this Court, the
20 parties having agreed to the entry of this order and judgment by
21 their stipulation, and good cause appearing;

22 This Court finds, concludes, and orders as follows:

23 FINDINGS OF FACT

24
25 1. Defendant RONALD ROY HAMLETT and plaintiff DIANA
26 LEE HAMLETT were married, and one minor child is the issue of
27 that marriage, namely DAVID HARLEY HAMLETT, born November 10,
28 1978.

1 2. Defendant and plaintiff were divorced on or about
2 October 22, 1981, and the decree of divorce in that matter filed
3 on or about October 22, 1981, ordered defendant to pay to DIANA
4 L. HAMLETT, for the support of said minor child, the sum of
5 \$25.00 per week.

7 3. Child support arrearages owing to plaintiff by
8 defendant in the amount of \$2,669.00 have accrued through and
9 including April 4, 1988.

10 4. Every finding of fact hereinabove which is held
11 upon review to be a conclusion of law is hereby adopted as such.
12

13 CONCLUSIONS OF LAW

14 1. This Court has jurisdiction of the subject matter
15 and the defendant.
16

17 2. Defendant owes a duty of support to his minor
18 child DAVID HARLEY HAMLETT, born November 10, 1978.

19 3. That the \$2,669.00 arrearage described in finding
20 of fact number 3 is a lawful arrearage. This conclusion is made
21 evident by NRS 130.280.
22

23 4. Every conclusion of law hereinabove which upon
24 review is held to be a finding of fact is hereby adopted as such.

ORDER AND JUDGMENT

1
2
3 1. Plaintiff shall have and recover judgment in the
4 amount of \$2,669.00, which sum represents child support
5 arrearages owing to plaintiff by defendant through April 4, 1988.

6 2. Defendant shall pay \$108.33 per month for the
7 current support of his minor child DAVID HARLEY HAMLETT, born
8 November 10, 1978.

9
10 3. Defendant shall pay \$11.67 per month toward
11 satisfaction of the outstanding \$2,669.00 child support
12 arrearage. When the child emancipates, the \$108.33 per month per
13 child support payments shall not cease, but shall continue and be
14 applied to child support arrears until said arrears are paid in
15 full or further order of the court.


16 4. Defendant's monthly \$108.33 ongoing child support
17 payment and \$11.67 payment on child support arrears, for a total
18 monthly sum of \$120.00, shall commence on May 15, 1988, and
19 continue on the 15th day of each month thereafter until the
20 child has emancipated and arrears are paid in full, or further
21 order of this court.

23 5. All child support payments made by defendant to
24 plaintiff pursuant to this order must be in the form of a
25 cashier's check, certified check, or money order, or in cash.
26 If the payment is in the form of cash it must be delivered to the
27 Douglas County Clerk at her office in Minden, Nevada. If the
28

1 payment is in the form of a cashier's check, certified check, or
2 money order, defendant understands that it must be made payable
3 to the DOUGLAS COUNTY CLERK and be either mailed to the Douglas
4 County Clerk at Post Office Box 218, Minden, Nevada 89423, or
5 delivered to said County Clerk at her office in Minden, Nevada.
6 The Douglas County Clerk shall transmit said payments to CLERK OF
7 THE CIRCUIT COURT, Child Support Division, Case No.
8 XO-09150137-A, P.O. Box 100, Jefferson County, Hillsboro, MO
9 63050.

10
11 6. An income or wage withholding may be sought by the
12 plaintiff if the defendant becomes thirty days or more delinquent
13 in making his child support payments.
