Kolvet, District Attorney for Douglas County, Nevada, representing the plaintiff, and defendant not personally appearing, but having agreed to the terms of this order in a telephone conversation with Lynda Caldwell, Child Support Officer, just prior to the hearing on March 14, 1988.

THE COURT FINDS AS FOLLOWS:

1. Through an examination of a copy of an Affidavit of Carolyn L. Williams, dated February 20, 1987, it appears there was an order made in the Superior Court of California, County of Sacramento, dated July 19, 1984, directing defendant to pay the 588 588 588 2477 178291

27 28 sum of \$100.00 per month for the support of his minor child DEREK DAVIS, born December 12, 1983.

- 2. Child support arrears which accrued during the period April 1, 1984, through January 31, 1987, are stated in the above-referenced affidavit as follows: amount due: \$3,400.00, amount paid \$713.00, support arrears through January 31, 1987: \$2,687.00.
- 3. Defendant has made no child support payments during the period February, 1987, through April, 1988, thereby increasing the child support delinquency by \$1,500.00, for a total delinquent sum of \$4,187.00 for the period April, 1984, through April, 1988.

THEREFORE, IT IS ORDERED, ADJUDGED AND DECREED as follows:


- 1. Defendant shall pay the sum of \$100.00 per month for the current support of his minor child, DEREK DAVIS, the first payment to be made on May 28, 1988, and continuing on the 28th day each month thereafter until said child reaches the age of majority or further order of the court.
- 2. That judgment shall be entered in favor of the plaintiff and against defendant for the sum of \$4,187.00 for the period April 1, 1984, through April, 1988.
- 3. That Defendant shall pay the additional monthly sum of \$25.00 toward said judgment, to be combined with his ongoing 178291

child support monthly payment of \$100.00, for a total of \$125.00 per month.

4. Said monthly payments shall be made by wage withholding, commencing upon entry of this order, and continuing monthly thereafter for 18 consecutive months or until arrears are paid in full, whichever is longer, or until further order of this Court. Said monthly payments by wage withholding shall be forwarded to the DOUGLAS COUNTY CLERK, Case No. 17929, Post Office Box 218, Minden, Nevada 89423. The Douglas County Clerk shall transmit said payments to the DISTRICT ATTORNEY OF SACRAMENTO COUNTY, STATE OF CALIFORNIA, Case No. 832125, Post Office Box 160937, Sacramento, CA 95816.
