15 The above-entitled matter having come on for hearing
16 May 16, 1988, pursuant to a Notice of Hearing filed by counsel
17 for plaintiff on April 29, 1988, present in Court was Brent T.
18 Kolvet, District Attorney for Douglas County, Nevada,
19 representing the plaintiff, and defendant not personally
20 appearing, but having agreed to the terms of this order in a
21 telephone conversation with Lynda Caldwell, Child Support
22 Officer, just prior to the hearing on March 14, 1988.

23 THE COURT FINDS AS FOLLOWS:

24
25 1. Through an examination of a copy of an Affidavit of
26 Carolyn L. Williams, dated February 20, 1987, it appears there
27 was an order made in the Superior Court of California, County of
28 Sacramento, dated July 19, 1984, directing defendant to pay the

1 sum of \$100.00 per month for the support of his minor child DEREK
2 DAVIS, born December 12, 1983.

3
4 2. Child support arrears which accrued during the
5 period April 1, 1984, through January 31, 1987, are stated in the
6 above-referenced affidavit as follows: amount due: \$3,400.00,
7 amount paid \$713.00, support arrears through January 31, 1987:
8 \$2,687.00.

9
10 3. Defendant has made no child support payments during
11 the period February, 1987, through April, 1988, thereby
12 increasing the child support delinquency by \$1,500.00, for a
13 total delinquent sum of \$4,187.00 for the period April, 1984,
14 through April, 1988.

15 THEREFORE, IT IS ORDERED, ADJUDGED AND DECREED as
16 follows:

17
18 1. Defendant shall pay the sum of \$100.00 per month
19 for the current support of his minor child, DEREK DAVIS, the
20 first payment to be made on May 28, 1988, and continuing on the
21 28th day each month thereafter until said child reaches the age
22 of majority or further order of the court.

23
24 2. That judgment shall be entered in favor of the
25 plaintiff and against defendant for the sum of \$4,187.00 for the
26 period April 1, 1984, through April, 1988.



28 3. That Defendant shall pay the additional monthly sum
of \$25.00 toward said judgment, to be combined with his ongoing

1 child support monthly payment of \$100.00, for a total of \$125.00
2 per month.

4 4. Said monthly payments shall be made by wage
5 withholding, commencing upon entry of this order, and continuing
6 monthly thereafter for 18 consecutive months or until arrears are
7 paid in full, whichever is longer, or until further order of this
8 Court. Said monthly payments by wage withholding shall be
9 forwarded to the DOUGLAS COUNTY CLERK, Case No. 17929, Post
10 Office Box 218, Minden, Nevada 89423. The Douglas County Clerk
11 shall transmit said payments to the DISTRICT ATTORNEY OF
12 SACRAMENTO COUNTY, STATE OF CALIFORNIA, Case No. 832125, Post
13 Office Box 160937, Sacramento, CA 95816.
