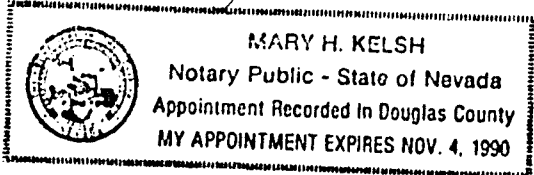

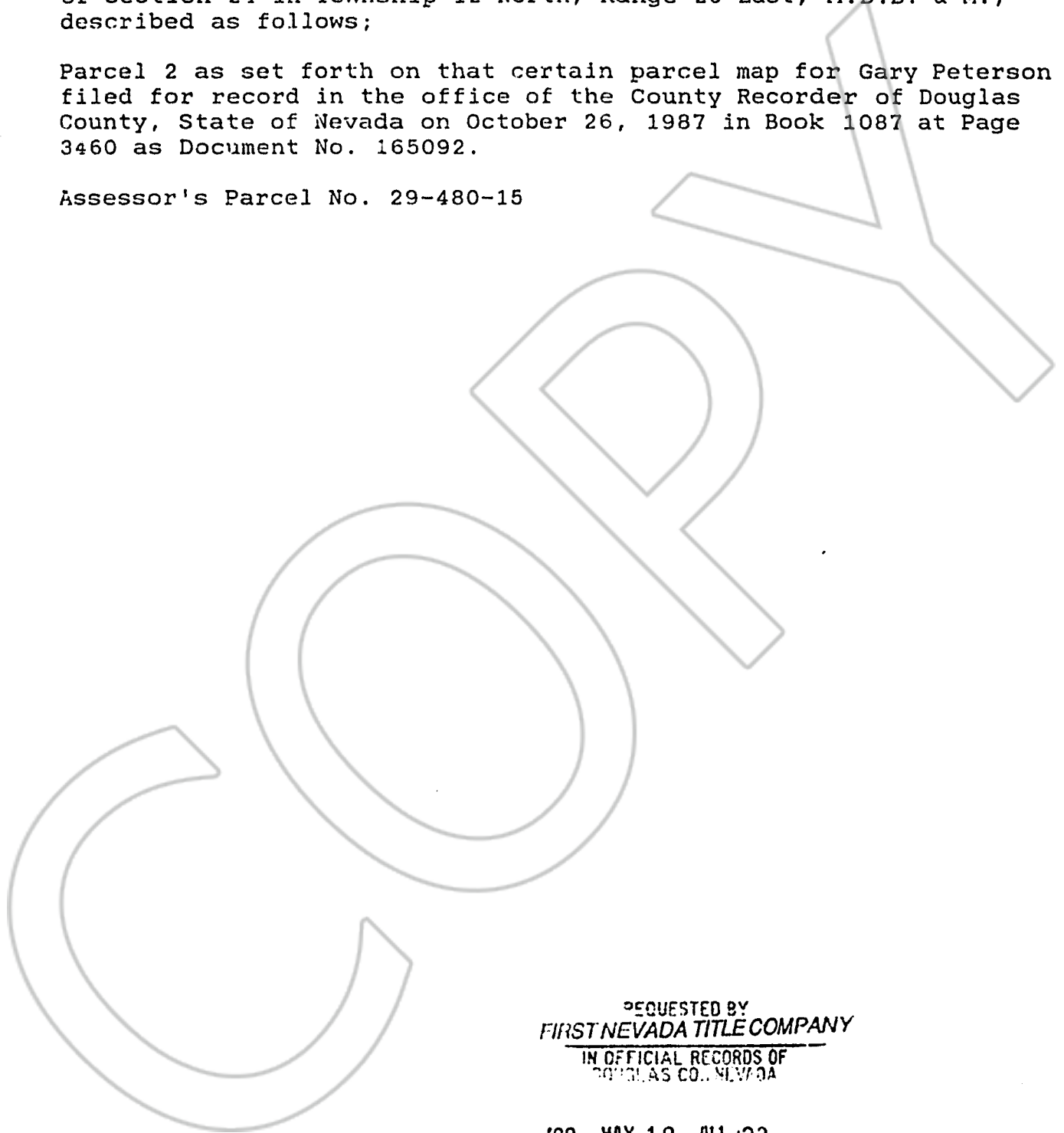
DESCRIPTION SHEET
