TERMS OF LOAN

By signing this agreement you are promising to pay Frontier Savings Association at its office in Reno the PRINCIPAL AMOUNT of this loan \$ 3,088.00 with the interest on the unpaid balance at the rate of 16.25 % per annum. The Finance Charge accrues from 11-7-85.

- You will make ONE Payment of \$ n/a due on n/a.
- Your payments will be due on the n/a day of each month beginning n/a and you agree to pay monthly installments of \$ n/a each, plus a final Balloon Payment of \$ n/a due on n/a.
- Your payments will be due on the 10th day of each month beginning 12-10-85 and you agree to pay 60 monthly installments of \$ 75.61 each, continuing until 11-10-90, when all unpaid principal and interest shall be paid in full.

CONDITIONS OF YOUR LOAN

By signing this agreement you also agree to the following conditions:

- You pay Frontier Savings Association a late charge on each full or partial payment not received at one of its statewide offices within 15 calendar days of its due date. This late charge will be 5% of the amount past due with a minimum of \$1.00 and a maximum of \$15.00.
- Your loan is UNSECURED Your loan is SECURED by (describe collateral)

which is further described in another document you will receive called a "Security Agreement." If you fail to make any payment by the date it is due, Frontier Savings Association may take possession of this collateral, sell it, and apply the proceeds from this sale to the balance due on your loan as provided in the Security Agreement. You remain obligated to pay off the remaining balance.
- If you fail to perform any of the terms or conditions of this agreement, Frontier Savings Association may charge any deposit account you might have with Frontier Savings Association to pay any amounts due on this loan. This is commonly referred to as Right of Offset. In addition, in the event of your failure to perform any of the terms or conditions of this agreement you promise to pay all collection costs and reasonable attorney's fees.
- Frontier Savings Association may delay enforcing any of its rights under this agreement without losing them.
- If you have not paid a payment within 15 days of the date it is due, Frontier Savings Association can, without notice or demand, declare the whole balance due and payable at once.
