FINDINGS OF FACT,
CONCLUSIONS OF LAW, AND ORDER

15 Upon application from Robert F. Balkenbush, Douglas
16 County Deputy District Attorney, at the request of Erwin William
17 Spier, this cause came on for hearing in the above-entitled Court
18 on the 17th day of May, 1988, with the following present: Deputy
19 District Attorney Harold Kuehn, counsel for plaintiff, and
20 defendant Erwin William Spier, appearing without counsel,

21 After considering all the evidence, the Court finds and
22 concludes that:

23
24 1. Defendant was ordered in an Interlocutory Judgment
25 of Dissolution of Marriage, Case No. 789758, on file in the
26 Superior Court of California, County of Sacramento, to pay
27 \$150.00 per month, beginning October 1, 1984, as and for child

1 support, for his minor child MICHELLE C. SPIER, born November 4,
2 1972.

3
4 2. As of March 31, 1988, defendant owes plaintiff the
5 sum of \$6,000.00 as child support arrears, defendant having paid
6 to plaintiff a total sum of \$150.00 as child support during the
7 period October, 1984, through March, 1988.

8 3. The court had personal jurisdiction over the
9 defendant when it issued the support order.

10
11 4. Defendant is at least 30 days delinquent in his
12 aforesaid child support payments.

13 Based upon the foregoing findings and conclusions, IT
14 IS HEREBY ORDERED that:

15
16 1. Plaintiff shall have and recover judgment in the
17 amount of \$6,000.00, which sum represents child support arrears
18 through March 31, 1988.

19 2. Defendant shall pay \$150.00 per month as ongoing or
20 current child support; the initial payment shall be due upon
21 entry of this order and subsequent payments shall be due on the
22 first day of each month thereafter until the minor child has
23 emancipated and child support arrears are paid in full or further
24 order of this Court.

1 3. Beginning December 1, 1988, defendant shall pay the
2 additional sum of \$50.00 per month toward the \$6,000.00 child
3 support arrearage, for a total monthly sum of \$200.00.
4

5 4. Said monthly payments shall be made by wage
6 withholding, commencing upon entry of this order, and continuing
7 monthly thereafter for 18 consecutive months or until arrears are
8 paid in full, whichever is longer, or until further order of this
9 Court. Said monthly payments by wage withholding shall be
10 forwarded to the DOUGLAS COUNTY CLERK, P.O. Box 218, Minden,
11 Nevada 89423. The Douglas County Clerk shall transmit said
12 payments to CYNTHIA C. O'DRISCOLL, P.O. Box 17398, So. Lake
13 Tahoe, CA 95706.

14 IT IS FURTHER ORDERED that defendant must advise the
15 Douglas County District Attorney's Office in writing or by
16 telephone within 10 days of every change in home address, mailing
17 address, or employment.
