The Court finds, concludes and orders as follows:

FINDINGS OF FACT

1. That CYNTHIA IRENE RODRIGUEZ is the mother and VICTOR GAVANO RODRIGUEZ is the father of minor children LEVI RODRIGUEZ, born November 23, 1974, and SUMMER RODRIGUEZ, born July 8, 1976.

- 2. That in its judgment and order dated September 14, 1978, judgment was awarded in favor of the County of Santa Clara and against defendant for the sum of \$5,341.84, which represents public expenditures made during the period November, 1976, to July, 1977, and October, 1977, to September, 1978.
- 4. That the balance of \$1,828.16 remains outstanding as of May 11, 1988. (Exhibits A and B attached).
- 3. Any finding of fact above-stated which upon review is held to be a conclusion of law is hereby adopted as such.

CONCLUSIONS OF LAW

- 1. That this Court has jurisdiction of the subject matter and the defendant.
- 2. A debt for the support of defendant's minor children LEVI RODRIGUEZ, born November 23, 1974, and SUMMER RODRIGUEZ, born July 8, 1976, in the sum of \$1,828.16, remains owing.
- 3. Any conclusion of law above-stated which upon review is held to be a finding of fact is hereby adopted as such.

ORDER


- 1. That plaintiff shall have and recover as a judgment against the defendant the amount of \$1,828.16.
- 2. That defendant shall pay the sum of \$100.00 per month, to be applied as payment on the \$1,828.16 debt for 178953

support. That the initial payment shall be due on June 15, 1988, and subsequent payments shall be due on the 15th day of each month thereafter until the \$1,828.16 debt for support is retired or satisfied or further order of this Court.

- defendant in either in the form of a cashier's check, certified check, or money order or in cash. - 4. Defendant is hereby advised that if his public assistance reimbursement payments become 30 days delinquent a wage withholding could be initiated pursuant to NRS Chapter 31A.
