1. Payment of Principal and Interest: Prepayment and Late Charges. Borrower shall promptly pay when due the principal of and interest on the debt evidenced by the Note and any prepayment and late charges due under the Note

2. Funds for Taxes and Insurance. Subject to applicable law or to a written waiver by Lender. 4. Charges; Liens. Borrower shall pay all taxes, assessments, charges, fines and impositions attributable to the Property which may attain priority over this Security Instrument, and leasehold payments or ground rents, if any. Borrower shall pay these obligations in the manner provided in paragraph 2, or if not paid in that manner. Borrower shall pay them on time directly to the person owed payment. Borrower shall promptly furnish to Lender all notices of amounts to be paid under this paragraph. If Borrower makes these payments directly, Borrower shall promptly furnish to Lender receipts evidencing the payments.

9. Condemnation. The proceeds of any award or claim for damages, direct or consequential, in connection with any condemnation or other taking of any part of the Property, or for conveyance in lieu of condemnation, are hereby assigned and shall be paid to Lender.

In the event of a total taking of the Property, the proceeds shall be applied to the sums secured by this Security Instrument, whether or not then due, with any excess paid to Borrower. THE NOTE CONTAINS PROVISIONS ALLOWING FOR CHANGES IN THE INTEREST RATE AND THE MONTHLY PAYMENT. THE NOTE LIMITS THE AMOUNT THE BORROWER'S INTEREST RATE CAN CHANGE AT ANY ONE TIME AND THE MAXIMUM RATE THE BORROWER MUST PAY. THE NOTE ALSO CONTAINS THE OPTION TO CONVERT THE AD-JUSTABLE RATE TO A FIXED RATE. THIS CONVERSION OPTION IS AT MY ELECTION.

ADDITIONAL COVENANTS. In addition to the covenants and agreements made in the Security Instrument, Borrower and Lender further covenant and agree as follows:

A. ADJUSTABLE INTEREST RATE AND MONTHLY PAYMENT CHANGES

The Note provides for an initial interest rate of 7.500 %. The Note provides for changes in the interest rate and the monthly payments, as follows:

4. ADJUSTABLE INTEREST RATE AND MONTHLY PAYMENT CHANGES

The interest rate the Borrower will pay may change on the first day of MAY 1989 and on that day everyTWELFTH month thereafter. Each date on which the interest rate could change is called a "Change Date.

(B) The Index

Beginning with the first Change Date, the interest rate will be based on an Index. The "Index" is the monthly weighted average cost of funds for the Eleventh District as published by the Federal Home Loan Bank of San Francisco. The most recent Index figure available as of the date 45 days before each Change Date is called the "Current Index."

If the Index is no longer available, the Lender will choose a new index which is based upon comparable information. The Lender will give the Borrower notice of this choice.

(C) Calculation of Changes

Before each Change Date, the Lender will calculate the new interest rate by adding TWO AND 65/100THS--percentage points (2.650%) to the Current Index. The Lender will then round the result of this addition to the nearest one-eighth of one percentage point (0.125%). Subject to the fimits stated in Section 4(D) below, this rounded amount will be the new interest rate until the next Change Date.

The Lender will then determine the amount of the monthly payment that would be sufficient to repay the unpaid principal that the Borrower is expected to owe at the Change Date in full on the maturity date at the new interest rate in substantially equal payments. The result of this calculation will be the new amount of the monthly principal and interest payment.

(D) Limits on Interest Rate Changes

The interest rate the Borrower is required to pay at the first Change Date will not be greater than % or less than 9.000 7. (F) Notice of Changes

The Lender will deliver or mail to the Borrower a notice of any changes in the interest rate and the amount of the monthly payment before the effective date of any change. The notice will include information required by law to be given the Borrower and also the title and telephone number of a person who will answer any question the Borrower may have regarding the notice.

FIXED RATE OPTION

The Note provides for the Borrower's option to convert from an adjustable interest rate with interest rate limits to a fixed interest rate, as follows:

FIXED RATE CONVERSION OPTION

(A) Option to Convert to Fixed Rate

The loan contains a provision that allows the Borrower to convert to a Fixed Rate loan for the remaining term anytime during the first five years provided the Borrower has not been delinquent during the 12 months prior to the request for conversion. The rate will be determined at the time the Borrower exercises the option based on the Lender's then current rate for fixed rate loans as calculated under Section 5(B) below.

If the Borrower wants to exercise the Conversion Option, the Borrower must first meet certain conditions. Those conditions are that: (i) the Borrower must give the Note Holder 15 days written notice that the Borrower wants to do so; (ii) on the Conversion Date, the Borrower must not be in default under the Note or Security Instrument; (iii) by a date specified by the Note Holder, the Borrower must pay the Note Holder a conversion fee equal to 1,000 % of the then current outstanding principal balance of the Note; and (iv) the Borrower must sign and give the Note Holder any documents the Note Holder requires to effect the conversion.

(B) Calculation of Fixed Rate

The new, fixed interest rate will be equal to the Federal Home Loan Mortgage Corporation's required net yield for 30-year, fixed rate mortgages covered by 60-day mandatory delivery commitments in effect as of the date 45 days before the Conversion Date, plus three-eighths of one percentage points (0.375%), rounded to the nearest one-eighth of one percentage point (0.125%), on loans with a balance of 68700 or less, or seven-eighths of one percentage point (0.875%), rounded to the nearest one-eighth of one percentage point (0.125%), on loans with a balance greater than 168700. Transfer of the Property or a Beneficial Interest in Borrower. If all or any part of the Property or any interest in it is sold or transferred (or if a beneficial interest in Borrower is sold or transferred and Borrower is not a natural person) without Lender's prior written consent, Lender may, at it's option, require immediate payment in full of all sums secured by this Security Instrument. However, this option shall not be exercised by Lender if exercise is prohibited by federal law as of the date of this Security Instrument. Lender also shall not exercise this option if: (a) Borrower causes to be submitted to Lender information required by Lender to evaluate the intended transferce as if a new loan were being made to the transferce; and (b) Lender reasonably determines that Lender's security will not be impaired by the loan assumption and that the risk of a breach of any covenant or agreement in this Security Instrument is acceptable to Lender.

Lender may also require the transferee to sign an assumption agreement that is acceptable to Lender and that obligates the transferee to keep all the promises and agreements made in the Note and in this Security Instrument. Borrower will continue to be obligated under the Note and this Security Instrument unless Lender releases Borrower in writing.

If Lender exercises the option to require immediate payment in full, Lender shall give Borrower notice of acceleration. The notice shall provide a period of not less than 30 days from the date the notice is delivered or mailed within which Borrower must pay all sums secured by this Security Instrument. If Borrower fails to pay these sums prior to the expiration of this period, Lender may invoke any remedies permitted by this Security Instrument without further notice or demand on

If Borrower exercises the Conversion Option under the conditions stated in Section B of this Convertible Adjustable Rate Rider, the amendment to Uniform Covenant 17 of the Security Instrument contained in Section C 1 above shall then cease to be in effect, and the provisions of Uniform Covenant 17 of the Security Instrument shall instead be in effect, as follows:

Transfer of the Property or a Beneficial Interest in Borrower. If all or any part of the Property or any interest in it is sold or transferred (or if a beneficial interest in Borrower is sold or transferred and Borrower is not a natural person) without Lender's prior written consent, Lender may, at it's option, require immediate payment in full of all sums secured by this Security Instrument. However, this option shall not be exercised by Lender if exercise is prohibited by federal law as of the date of this Security Instrument.

If Lender exercises this option, Lender shall give Borrower notice of acceleration. WAIVER OF RIGHT TO A JURY TRIAL

The Borrower hereby expressly waives any right to a trial by jury in any action or proceeding to enforce or defend any rights under this Deed or Rider or under any amendment, instrument, document or agreement delivered (or which may in the future be delivered) in connection herewith or arising from any banking relationship existing in connection with the Deed or Rider. The Borrower agrees that any such action or proceeding shall be tried before a court and not before a jury.

E. CHOICE OF LAW; EFFECT OF INVALIDITY OF PROVISIONS

This Agreement and the Borrower's rights and duties under it shall be governed by laws of the State of Nevada. If any provision in this Deed or Rider is deemed unenforceable or illegal by a court competent to so rule, then the offending words will be stricken and all remaining provisions shall remain in full force and effect.

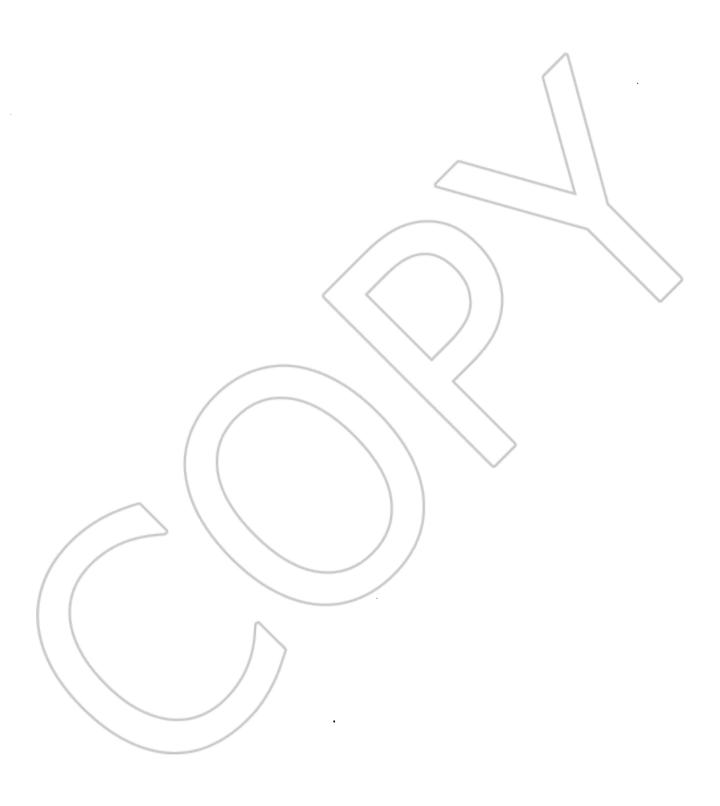
