The above-entitled matter having come before this Court
on an Application for Default judgment on the 27th day of April,
1987, Plaintiffs being represented by Robert F. Balkenbush,
Deputy District Attorney, Douglas County, Nevada, and Defendant
failing to appear,

Defendant BRIAN WITHROW having been duly served with a
Summons and Complaint in the above-entitled matter on the 27th
day of February, 1987, and having failed to answer or otherwise
appear as required by law and a default issued, the Court finds
the Plaintiff is entitled to the relief prayed for in the
complaint;

1 THEREFORE, IT IS ORDERED, ADJUDGED AND DECREED as
2 follows:

3 1. That Plaintiff shall have and recover judgment in
4 the amount of \$1,070.00, which represents reimbursement for
5 public assistance paid by Plaintiff for the support of
6 Defendant's minor children RENEE LEE WITHROW and MICHAEL JAMES
7 WITHROW, from January 1, 1986 to May 31, 1986.

8 2. That Defendant shall pay said sum in installments
9 of not less than \$100.00 per month, the first payment to be made
10 on May 20, 1987, and continuing on the same day each month
11 thereafter until said sum is paid in full or further order of the
12 court.

13 3. That Defendant shall make said payments in the form
14 of a cashier's check or money order made payable to CLERK OF
15 COURT, DOUGLAS COUNTY, and transmitted to Clerk of Court, Douglas
16 County, P.O. Box 218, Minden, Nevada 89423, which Clerk of Court
17 shall transmit payments to Family Support Division, 208 North
18 Carson Street, Carson City, Nevada 89701.
