as trustee under said deed of trust as shown above

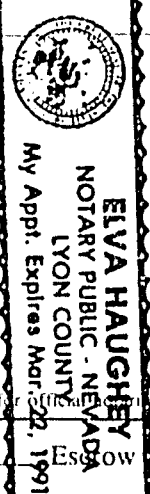
