

Certificate of Location of Lode Mining Claim

The claim is 1500 feet long and 600 feet wide, and 50 feet is claimed in a NW direction and 1450 feet in a SE direction from the location monument, at which the Notice of Location is posted, lengthwise of the claim, together with 200 feet in width on each side of the center of the claim. The general course of the lode deposit and premises is from the NORTH EAST to the SOUTH WEST.

The location and number of each corner of this claim is shown on the claim map that is filed herewith. On the ground, each corner of the claim is marked with its appropriate number by PAINT BLACKS

- Corner No. 5 is a 4x4 wood post painted SE cor. ED #1
- Corner No. 6 is a 4x4 wood post painted E side center ED #1

The monumentation and marking of the corners was completed by the 29 day of June, 1988

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this claim map have been filed with DOUGLAS County Recorder, and the \$15.00 lode claim filing fee has been paid to the County Recorder.
