- The LAST WILL AND TESTAMENT of the deceased was filed in the above-entitled Court on November 10, 1981.
- Letters Testamentary were issued to **JAMES** D. McGEE on December 22, 1981.
- Notice to Creditors was filed on January 1982, and was duly published as required by law with proof of publication filed on March 15, 1982.
- creditor's claim filed SECURITY One was by PACIFIC BANK OF CALIFORNIA on March 3, 1982, with refiled on March 16, 1982, for \$1,572.77. No action was taken on the claim after a notice of rejection was filed and served on the claimant on August 12, 1982. The claim is, therefore, waived in accordance with N.R.S. 147.130.

5. The Final Accounting was completed and dated April 13, 1983, and duly filed thereafter and appears in all respects to be accurate and in order as well as complying with Nevada law.

- The Notice of the Hearing on the Petition for 6. Approval of the Final Accounting and Decree of Distribution was made in accordance with Nevada law.
- 7. The decedent died leaving a written will which was executed prior to his marriage to MICHELE McGEE. dent was married to MICHELE McGEE at the time of his death. While there is no mention of the said MICHELE McGEE in the WILL since it was executed prior to the marriage, N.R.S. 133.010 therefore creates a presumption that the Decedent intended that the WILL be revoked as to the Wife. Pursuant to NRS 134.040, MICHELE McGEE would then be entitled to one-third (1/3) of the Estate.
- The Executor and MICHELE McGEE have entered into an agreement whereby MICHELE McGEE agrees to receive certain funds distributed from the Estate in lieu of any claimed share of the remainder of the Estate.

Based upon the findings above, the Court hereby orders and decrees as follows:

- The Final Accounting filed in this matter is approved.
- The agreement between the widow, MICHELE McGEE and the Executor, dated March 31, 1983, is approved in all respects, and in accordance therewith, the Executor is directed to distribute such property in his possession to the widow in accordance therewith; specifically, the Wife may retain all advanced monies from the Estate totaling \$8,894.00. The Executor is directed to pay to the Wife in addition thereto, the sum of \$8,167.45. Wife, by accepting said monies, conveys any

and all interest she may have as an heir to the Estate in the real property to the remaining heirs and waives any and all claim to any other asset of the Estate.

- (3) The rest and remainder of the Estate shall be distributed to the trust created for the benefit of the surviving children of the decedent in accordance with the trust document prepared and executed by the Decedent with JAMES D. McGEE as Trustee.
- (4) All previous disbursements made by the Executor in accordance with previous court orders are again approved.
- (5) Upon distributing the Estate in accordance with this Order and Decree, and upon providing satisfactory proof thereof, the Executor shall be discharged from any and all further duties in this matter.
