- That the Court does in all respects settle, allow, approve and confirm the First and Final Account, Report, Petition for Allowances and Petition for Final Distribution and does hereby direct distribution of the assets of the Estate as provided in the lost Will of HERMIE CARLENE GOODSELL, deceased.
