The above-entitled matter came on for hearing October 24, 1988, pursuant to Show Cause order entered September 21, 1988, present in court were Robert F. Balkenbush, Deputy District Attorney for Douglas County, Nevada, representing the plaintiff, and defendant appearing without counsel.

The Court finds, concludes and orders as follows:

FINDINGS OF FACT

1. That in an Order of Approval, filed May 27, 1982, the Eighth Judicial District Court of the State of Nevada in and for the County of Clark, defendant was ordered to reimburse plaintiff for public assistance paid for the support of his minor child RYAN ANTHONY SCALISE, born October 7, 1976, in the amount

1 of \$1,515.00 to be paid at the rate of TWENTY-FIVE (\$25.00) per
2 month, commencing May 25, 1982.

3 2. Defendant was further ordered to advise the
4 District Attorney's Office, Family Support Division, in writing
5 or by telephone, WITHIN TEN (10) DAYS OF EVERY change in home
6 address or employment.

7 3. That defendant has made some payments and an
8 outstanding balance of \$1,173.90 remains due and owing plaintiff.

9 4. Any finding of fact above-stated which upon review
10 is held to be a conclusion of law is hereby adopted as such.

11 CONCLUSIONS OF LAW

12 1. In this proceeding, this Court has jurisdiction of
13 the defendant and the subject matter.

14 2. Any conclusion of law above-stated which upon
15 review is held to be a finding of fact is hereby adopted as such.

16 ORDER

17 1. That defendant shall pay \$25.00 per month as
18 reimbursement of a \$1,173.90 debt for support. That the initial
19 payment shall be due on November 1, 1988, and subsequent payments
20 shall be due on the first day of each month thereafter until the
21 \$1,173.90 debt for support is retired or further order of this
22 Court.


23 2. That the monthly \$25.00 installments and all
24 payments on the \$1,173.90 debt for support shall be made by
25 defendant either in the form of a cashier's check, certified
26 check or money order or in cash. If the payment is in the form
27

1 of cash, it must be delivered to the Douglas County Clerk at her
2 office in Minden, Nevada. If the payment is in the form of a
3 cashier's check, certified check or money order, it must be made
4 payable to the DOUGLAS COUNTY CLERK, and be either mailed to the
5 Douglas County Clerk at P.O. Box 218, Minden, Nevada 89423, or
6 delivered to said County Clerk at her office in Minden, Nevada.
7 The Douglas County Clerk shall transmit said payments to the
8 FAMILY SUPPORT DEPT., DISTRICT ATTORNEY'S OFFICE, EL DORADO,
9 COUNTY, Case No. R13448, 515 Main St. Placerville, CA 95667.

10 3. That defendant shall notify the Douglas County
11 District Attorney's Office in writing or by telephone, within ten
12 (10) days of every change in mailing address, home address and
13 employment.

14 4. That failure to make a monthly \$25.00 payment shall
15 result in that amount being withheld by wage withholding without
16 further notice to the defendant.
