15 This case came before the Court on Ribeiro's Motion to  
16 Dismiss and for Sanctions. For reasons stated in the Findings of  
17 Fact and Conclusions of Law filed on June 6, 1988,

18 IT IS HEREBY ORDERED ADJUDGED AND DECREED:

19 1. Plaintiff Bill Young's (YOUNG) Second Amended Complaint  
20 shall be, and it hereby is, dismissed with prejudice.

21 2. The accounting furnished by defendant Johnny Ribeiro  
22 Builder, Inc. (RIBEIRO) and authenticated by the Affidavit of  
23 Lloyd Kirchner is approved as the final accounting between  
24 Young and Ribeiro for the D'Atri, Young, Badgley and Ribeiro  
25 partnership.


1 3. Ribeiro has judgment against Young for the sum of  
2 \$49,817.24 as sanctions, together with interest thereon from  
3 the date of the original judgment until paid.

4 4. The D'Atri, Young, Badgley and Ribeiro partnership,  
5 and the D'Atri-Young limited partnership are herewith dissolved,  
6 and Ribeiro and John D'Atri shall proceed to wind up the affairs  
7 of the partnership by selling the assets of the partnerships and  
8 distributing the remainder of the partners in the following  
9 proportions:

- 10 1. 33 1/3% to Ribeiro;
- 11 2. 33 1/3% to D'Atri; and
- 12 3. 33 1/3% to Young

13 but D'Atri and Ribeiro shall pay Ribeiro such amounts from the  
14 amounts available for distribution to Young as may remain unpaid  
15 upon the judgment entered herein in favor of Ribeiro and against  
16 Young.


