4. The following covenants, Nos. 1.3,4 (i the heirs, representatives, successors and assignes of the parties hereto and the Beneficiary hereof.

Whenever used, the singular number shall include the plural, the plural the singular and the use of any gender shall include all other genders, and the term "Beneficiary" shall include any payee of the indebtedness hereby secured or any transferce thereof whether by operation of law or otherwise. law or otherwise.
