GENERAL

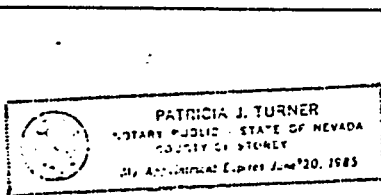
