## ABANDONMENT:

## AN ORDER OF ABANDONMENT VACATING A PORTION OF THE WESTERLY RIGHT-OF-WAY OF LIBRARY LANE

WHEREAS Douglas County, a political subdivision of the State of Nevada, presently holds an easement interest within the Southeast 1/4 of Section 30, Township 13 North, Range 20 East, MDB&M, for portions of that certain road right-of-way commonly known as Library Lane; and,

WHEREAS Douglas County, pursuant to the provisions of NRS 278.480 may vacate or abandon by formal order any portion of a public roadway which is in excess of its needs; and,

WHEREAS on July 21, 1988, the Douglas County Planning Commission held a public hearing in conformance with the provisions of NRS 278.240 to take testimony for said abandonment and did find that the release of a portion of Library Lane as defined in Exhibit "A", attached hereto, would not have an adverse effect on the Douglas County Master Plan; and,

WHEREAS on August 3, 1988, the Town of Minden held a public hearing, and did find in favor of the abandonment of the subject portion of Library Lane; and,

WHEREAS on August 8, 1988, the Board of Douglas County Commissioners held a public hearing to take testimony for said abandonment and did find that the subject portion of Library Lane is in excess of the needs of Douglas County.

NOW THEREFORE be it ordered by the Board of Douglas County Commissioners, that the following described right-of-way and incidents thereto, being all that certain piece or parcel as defined in Exhibit "A", is hereby abandoned subject to the following conditions and stipulations:

- 1) The abandoned portion shall revert and be deemed as being attached to Parcel "A-1-2" of Parcel Map #2 for Mack Land and Cattle Company as filed for record on January 25, 1985, in Book 185, at Page 2070, as Document Number 112841 of the Official Records of Douglas County Nevada.
- This abandonment is solely for the release of the public roadway interest, and it is hereby confirmed that a Public Utility Easement is expressively reserved for the continuation, maintenance, expansion, and operation of the public utilities contained within the limits of this abandonment.
