AN ORDER OF ABANDONMENT VACATING A PORTION OF GENOA STREET.

WHEREAS Douglas County, a political subdivision of the State of Nevada, presently holds an easement interest within the southeast 1/4 of the northeast 1/4 of Section 9, Township 13 North, Range 19 East, MDB&M, for portions of that certain road right-of-way commonly known as Genoa Street. A portion of said easement is more fully shown and delineated as being that certain parcel designated as "Abandoned Acreage" as portrayed on the "Record of Survey to Accompany Road Abandonment and Lot Line Adjustment for David & Suzanne Beres" as recorded March 28, 1989 in Book 389 at Page 3967 as Document Number 199133 of the Official Records of Douglas County Nevada; and,

WHEREAS Douglas County, pursuant to the provisions of NRS 278.480 may vacate or abandon by formal order any portion of a public roadway which is in excess of its needs; and,

WHEREAS on April 5, 1988, the Town of Genoa held a public hearing, and did find in favor of the abandonment of the subject easement; and,
