

PARTIAL RELEASE OF JUDGMENT LIEN

3 (\$300.00) for each interval unit received and held in trust by
4 Stewart Title of Douglas County acting as escrow agent for the
5 judgment plaintiff, Econ Marketing, Inc. and in accordance with

26 attached hereto whereby the respective customers purchased an

1 interval time share unit from Capri Resorts, Inc. True copies of

3 Exhibits A's thereto are hereby incorporated herein by reference
4 as if fully set forth herein.

6 or purchasers, his or her or their heirs, assigns or successors
7 in interest irrespective of whether such transfer be by operation
8 of law or otherwise.

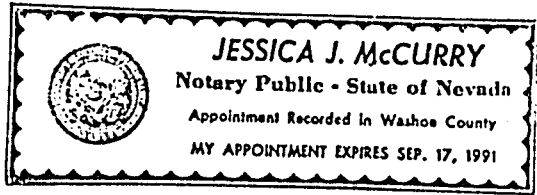
