PARTIAL RELEASE

THIS PARTIAL RELEASE, made this 29 day of Whole, 19 19, by and between Capri Resorts, Inc., hereinafter "Developer", and Donald C. Hill, hereinafter "Counselor".

WITNESSETH

WHEREAS, the Parties hereto have entered into certain attorneys fees and lien agreements for the payment of attorneys fees and costs to Counselor; and

NOW, THEREFORE, in consideration of the covenants and promises contained in the aforementioned attorneys fee and lien agreements and as set forth herein Counselor agrees to release his interest only in the simple week timeshare units described in Exhibit "A" attached hereto.

This Partial Release shall be recorded with the Douglas County Recorder's Office as a condition to the close of escrow of said timeshare unit. This Partial Release may be revoked by Counselor at any time upon written notice to Stewart Title of Douglas County without any liability therefore being incurred by Counselor or any title company.
