HENDRICKSON, surviving nephew, ALAN M. HENDRICKSON, surviving nephew, and LISA J. HENDRICKSON, surviving niece of the decedent, came on regularly for hearing by

the Court this date. Petitioner was represented by her counsel, SHEERIN, WALSH & KEELE and GEORGE M. KEELE, ESQ.

The Court finds from the proof made to the satisfaction of the Court:

- 1. That the decedent JOSEPH SIPKA died intestate on or about 4th day of August, 1988, in Medford, Oregon, and left real property situate in Douglas County, State of Nevada.
 - 2. That all notices have been duly given as required by law.
 - 3. That all facts alleged in the Petition are true.
- 4. That the gross value of the whole estate of after deducting any encumbrances does not exceed TWENTY-FIVE THOUSAND DOLLARS (\$25,000) as of the date of decedent's death.
- 5. That there are no payments due for funeral expenses, expenses of last illness, creditors' claims, or debts of any type or nature.
- 6. That the Petitioner, ANNE SIPKA WURSTER, is the surviving sister of the decedent, and that the decedent was not married and had no children.
- 7. That the law firm of SHERRIN, WALSH & KEELE has provided to Petitioner in excess of 11.60 hours of valuable legal services with a reasonable value of One Thousand One Hundred Sixty Dollars (\$1160.00).
- 8. That the law firm of SHEERIN, WALSH & KEELE has advanced on behalf of Petitioner costs in the amount of Five Hundred Twenty-Five Dollars (\$525.50).

Based upon the foregoing facts, the court concludes that the Petitioner is entitled to the relief provided by the provisions of Section 146.070 of NRS.
