4. There is no outstanding writ of execution for enforcement of this Judgment.



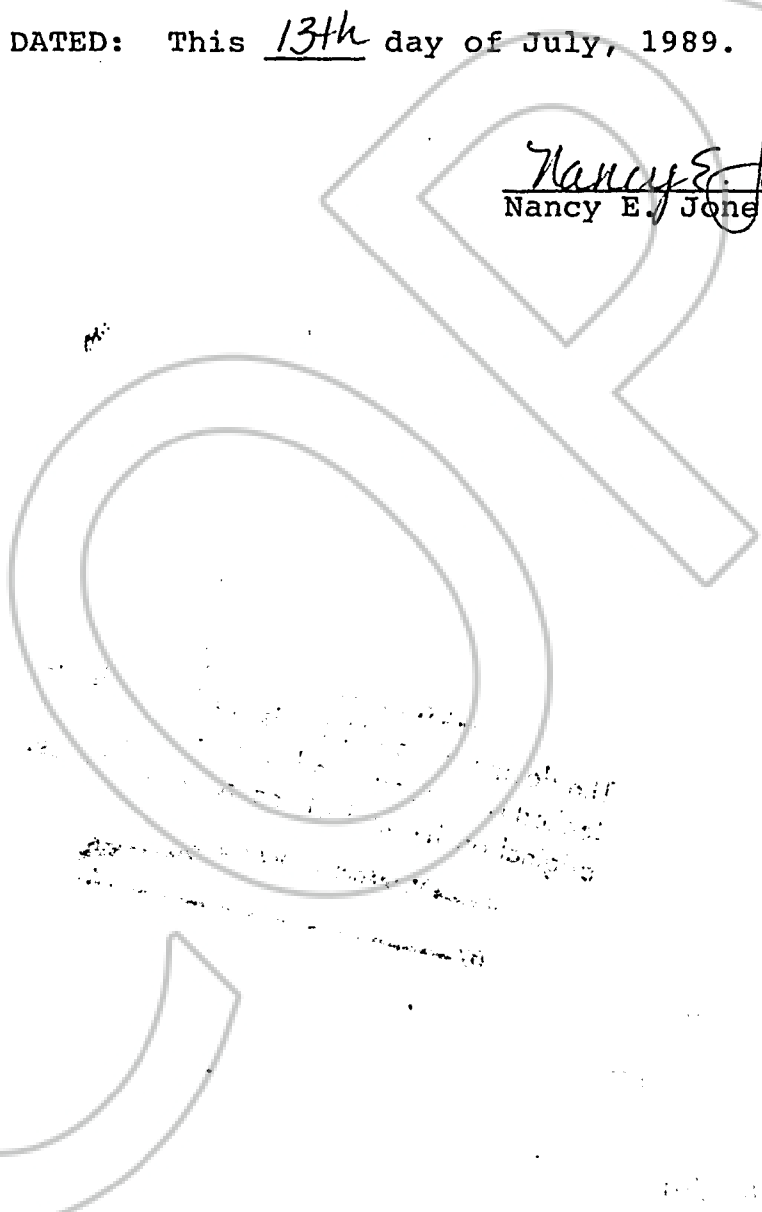
