AGREEMENT

THIS AGREEMENT is made and entered into this 20th day of BANGLY, 1989, between the MINDEN-GARDNERVILLE SANITATION DISTRICT (hereinafter referred to as MGSD), and DOUGLAS COUNTY, NEVADA, a political subdivision of the State of Nevada (hereinafter referred to as COUNTY).

RECITALS

1. The COUNTY entered into a maintenance and testing agreement with MGSD for monthly testing and weekly observation of the Douglas County owned North Valley Sewage Treatment Plant, covering a period from July, 1988 to June, 1989.

2. The COUNTY is desirous of entering into a similar maintenance and testing agreement with MGSD for a period covering July 1, 1989 to June 30, 1990.

NOW, THEREFORE, in consideration of the mutual understanding of the parties, they do agree as follows:

1. MGSD agrees to take the monthly tests necessary to fulfill the requirements of the Douglas County Discharge Permit number NEV 60025, from July 1, 1989, to June 30, 1990.

2. MGSD agrees to send samples taken from the observation wells to the outside testing lab for tests that cannot be conducted by MGSD.

3. MGSD agrees to make weekly reasonable visual inspections of the North Valley Sewage Treatment Plant and

inform the County in writing of any problems MGSD observes that it deems should be corrected.

4. The COUNTY agrees to reimburse MGSD for labor and mileage for testing and weekly inspections at the agreed initial rate as shown in Exhibit "A". The COUNTY understands and agrees that the rates set forth in Exhibit "A" may change due to increases in expenses incurred by MGSD for mileage and salaries paid by MGSD for its employees.

5. The COUNTY agrees to pay the outside testing lab for tests that cannot be conducted by MGSD on the observation wells.

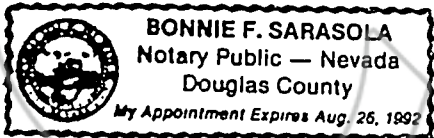
Both parties further agree that this agreement will be in effect from July 1, 1989, to June 30, 1990.


