MAINTENANCE AGREEMENT

THIS AGREEMENT is entered into this 31st day of May,

Willow Bend, Douglas County, Nevada, being Assessor's Parcel Number 17-140-17 and 17-140-18, which properties share a thirty (30) foot private driveway roadway, as set forth on that certain parcel map recorded in the official records of Douglas County as Document , Page 920 #<u>195996</u> at Book <u>289</u> February 8, 1989, on Certificate of Amendment recorded March 10, 1989 in Book 389 at page 1334; Second Party has reached a separate agreement with Doc #197916. First Party for the purchase of Parcel 6A, and in connection therewith has agreed to enter into this Maintenance Agreement to the provide for the maintenance and repair of roadway and appurtenances by First and Second Party.

NOW, THEREFORE, in consideration of the promises and covenants contained herein, and for other and valuable consideration, receipt of which is hereby acknowledged, the parties agree as follows:

- 1. First and Second Party shall have equal rights and obligations regarding the thirty (30) foot private access and public utility easement as set forth on the parcel map, and agree to equally share all costs and expenses thereof.
- 2. The parties agree to maintain an annual assessment on each party in the amount of each party in the amount of Two Hundred Fifty Dollars (\$250) per year to establish a fund for the proper future maintenance, repair, and replacement of the easement and facilities thereon. Such amount shall be due annually in advance, on the first day of June of each year. All said funds shall be deposited and maintained in a joint account as established and agreed by the parties. Said amounts and any provisions for the use and distribution thereof may be changed only by further written agreement of the parties.
- 3. The funds contributed and accumulated by the parties shall be used for the maintenance, repair, and replacement of the road and bridge currently existing. Maintenance shall be undertaken yearly to maintain the roadway and bridge in its existing condition. Expenditures of funds for other than such annual maintenance and repair shall require the joint agreement of the parties.
- 4. This Agreement and the benefits and burdens thereof shall inure to the grantees, successors, heirs, assigns, and representatives of each party.
 - 5. This Agreement shall be specifically enforceable.
