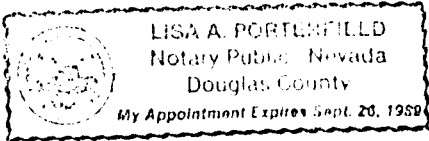
That the Homestead herein declared is the principal dwelling of the declared Homestead owners;
