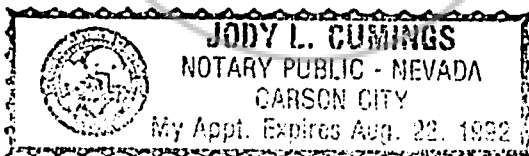

Declaration of Homestead (Husband and Wife)
