THE PROPERTY MAY THEREAFTER BE SOLD.



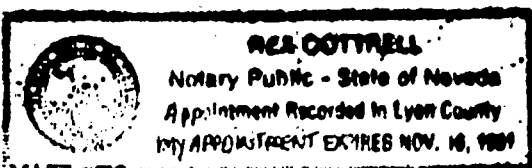
