19 1. ___ This petition and supporting documents be returned to the
20 initiating jurisdiction for location of the defendant/
respondent.

21 2. ___ This case be dismissed.

22 3. That the defendant/respondent is the parent of the
following children:

25 4. Judgment is entered in favor of plaintiff/petitioner

5. Judgment is entered in favor of plaintiff/petitioner and against defendant/respondent in the amount of _____ for reimbursement.

6. That defendant/respondent shall pay \$300.00 per month while accruing child support arrears in the amount of \$400.00 per month, beginning October 15, 1989, to be paid as follows:

7. The defendant/respondent shall provide health insurance obtaining payment for insured services.

8. The defendant respondent shall pay medical expenses, including dental and ophthalmological services for the child(ren) as follows:

1) Defendant shall pay for all medical and dental expenses for his minor children which are unreimbursed by insurance.

9. The defendant/respondent shall notify the Court/Administrative Agency of any change of address/employment within 10 days.

10. It is further ordered that

1) Defendant shall make his \$300.00 monthly child support payments in accordance with paragraph no. 11 of the stipulation entered in this Court on October 3, 1989.

2) Defendant's monthly payments shall be made by defendant on or before the 15th day of each month.

3) This case will be heard on Monday, October 8, 1990, for the purpose of determining whether defendant has then the ability to pay his full \$700.00 monthly child support obligation, and whether defendant has then the ability to pay any amount toward retirement of his child support arrears.

11. X NOTICE: This is an income withholding order. Support payments in arrears by 30 days may be withheld from income without further order of any court or further application for services.
