
Larry L. Lackey, being duly sworn, deposes and says:

That he is a citizen of the United States and more than eighteen years of age, resides at Morrison, in Jefferson County, Colorado, is the Manager, U.S. Exploration, for Western Gold Exploration and Mining Company, Limited Partnership, a Delaware limited partnership qualified to do business in Nevada, and is personally acquainted with the unpatented mining claims listed in Exhibit "A", attached hereto and by this reference made a part hereof; said claims are situated in the Buckskin and Mason Mining Districts, Douglas and Lyon Counties, Nevada, the location certificates of which are of record in the office of the County Recorder, and assigned serial numbers by Bureau of Land Management as set forth in said Exhibit "A".

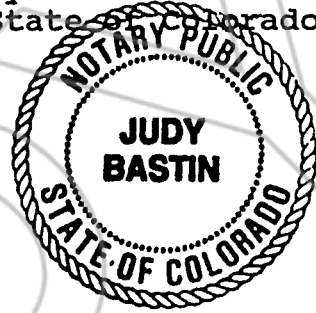
