AFTER CONSIDERING ALL OF THE EVIDENCE, THE COURT FINDS:

1. That the Court has jurisdiction of the parties and subject matter of this case.
2. That the defendant/respondent is the parent of the following child/ren:

RACHEL HARDING

Born: September 25, 1972

1 3. That the defendant/respondent owes a duty of support to
the following dependent/s:

2 RACHEL HARDING Born: September 25, 1972

3 4. That \$50.00 per month is a reasonable amount of support
for defendant/respondent to pay.

4 5. That the defendant/respondent owes reimbursement in the
5 amount of \$2,350.00 through November 30, 1989.

6 6. The Court further finds that:

7 (1) Defendant's minor child RACHEL HARDING, has
8 been in foster care in El Dorado County, California,
since March, 1988.

9 (2) El Dorado County, California has provided,
10 and is currently providing, welfare monies in support
of defendant's minor child RACHEL HARDING.

11 (3) Defendant submits that his daughter will
12 return to his care and custody in April, 1990.

13 THEREFORE, IT IS HEREBY ORDERED THAT:

14 1. That the defendant/respondent is the parent of the
following child/ren:

15 RACHEL HARDING Born: September 25, 1972

16 2. Judgment is entered in favor of plaintiff/petitioner
17 COUNTY OF EL DORADO, et al., and against defendant
in the amount of \$2,350.00 for reimbursement.

18 3. That defendant/respondent shall pay \$100.00 per month,
19 to be paid as follows:

20 PAYEE: DOUGLAS COUNTY CLERK	CHILD SUPPORT	\$ 50.00

23 4. That defendant shall inform the Douglas County
24 District Attorney's Office when his minor child
RACHEL HARDING, returns to his care and custody.

25 5. That when RACHEL HARDING returns to the care and
26 custody of the defendant, defendant's monthly
27 child support obligation shall be reduced to \$50.00
per month for reimbursement.

1 6. The defendant/respondent shall notify the Court of any
change of address/employment within 10 days.

2 7. It is further ordered that:

3 (1) Defendant's first \$100.00 monthly child
4 support obligation shall be due on or before
5 December 15, 1989, and shall continue due on the
15th of every month thereafter until further order
of this Court.

6 (2) That defendant's ordered \$50.00 monthly
7 payment on child support reimbursement does not
8 preclude other methods of collection for child
support arrears.

9 (3) Defendant's monthly child support
10 obligation shall be made by defendant either in the
11 form of a cashier's check, certified check, money
12 order, or in cash. If the payment is in the form of
13 cash, it must be delivered to the Douglas County
14 Clerk at her office in Minden, Nevada. If the
15 payment is in the form of a cashier's check,
16 certified check, or money order, it must be made
17 payable to the DOUGLAS COUNTY CLERK, must
contain the notation Case No. 22495 (HARDING), and
be either mailed to the Douglas County Clerk at
Post Office Box 218, Minden, Nevada 89423,
or delivered to said County Clerk at her
office in Minden, Nevada. The Douglas County
Clerk shall transmit said payments to El Dorado
County District Attorney, Family Support Division,
(Case No. 14215-6), P.O. Box 1045, Placerville, CA
95667.

18 8. NOTICE: This is an income withholding order. Support
19 payments in arrears by 30 days may be withheld from income
20 without further order of any court or further application
21 for services.
