ASSIGNMENT OF JUDGMENT

KNOW ALL MEN BY THESE PRESENTS, that I, George W. Abbott, of Woodfords, Alpine County, California, temporarily residing in the Town of Minden, Douglas County, Nevada, in consideration of certain monetary obligations owing to Marie M. Abbott, and in consideration of love and affection running to Jeanne Marie Abbott, George Walter Abbott, and Christopher William Abbott, do hereby transfer and assign to The Abbott Trust, domiciled in the State of Nevada, with a mail address at 520 Foothill Road, Gardnerville, Nevada, 89410, and a business address at 1540 Fourth Street, Minden, Nevada, 89423, that certain judgment recovered by me against John B. "Tito" Pordon and Barbara A. Pordon and Mary Sbragia, individually, and jointly and severally, in the Ninth Judicial District Court of the State of Nevada, in and for the County of Douglas on the 12th day of May, 1988, and I do hereby also transfer and assign to the said The Abbott Trust, that certain supplemental judgment entered on my behalf and recovered by me against the selfsame John B. "Tito" Pordon and Barbara A. Pordon and Mary Sbragia, individually, and jointly and severally in the Ninth Judicial District Court of the State of Nevada, in and for the County of Douglas on the 5th day of December, 1988, which judgment and supplemental judgment, of which transcripts by photo copy are attached, awarded to George W. Abbott, assignor here, the sum of \$65,535.29 in principal amount due as of October 22, 1979, with interest to accrue at the rate of twelve percent (12%) compounded monthly, from and after October 22, 1979 and until paid.

This assignment includes irrevocably the transfer of all my right, title and interest, claim and demand therein, with full authority in The Abbott Trust to demand and receive the amount of said judgment to the Trust's own use, and upon payment of said judgment or any part thereof to give to the said judgment debtors a discharge thereof, and I, the said George W. Abbott do hereby authorize the said The Abbott Trust to sue out execution and all other legal process necessary to the enforcement of the said judgment and supplemental judgment.

And I, the said George W. Abbott, do hereby covenant with the
