4 for defendant/respondent to pay.

5 5.  That the defendant/respondent owes reimbursement in the  
6 amount of \$1,540.00 as of January 31, 1990.

6 2) Defendant's ordered \$20.00 monthly payment  
7 on child support arrearages does not preclude other  
8 methods of collection for child support arrears.

9 3) This support order shall be reviewed every  
10 three years in accordance with Nevada Revised  
11 Statute 125B.145.

12 7.  NOTICE: This is an income withholding order. Support  
13 payments in arrears by 30 days may be withheld from income  
14 without further order of any court or further application  
15 for services.
