IN WITNESS WHEREOF, the said GEORGE L. STEWART has executed these presents this 5th day of February, 1990.

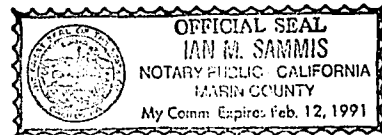
