ORDER AND JUDGMENT

This matter was settled by written stipulation of the parties.

AFTER CONSIDERING ALL OF THE EVIDENCE, THE COURT FINDS:

1.  That the Court has jurisdiction of the parties and subject matter of this case.
2.  That the defendant/respondent is the parent of the following child/ren:

HAROLD WFSLEY ROBERT WILLARD Born: March 28, 1988

1 3.  That the defendant/respondent owes a duty of support to  
2 the following dependent/s:

3 HAROLD WESLEY ROBERT WILLARD Born: March 28, 1988

4 4.  That 110.00 per month is a reasonable amount of support  
5 for defendant/respondent to pay.

6 5.  That the defendant/respondent is in arrears in the  
7 amount of \$990.00 as of March, 1990.

8 6.  That the defendant/respondent owes reimbursement of  
9 paternity blood testing costs to the Douglas County  
10 District Attorney's Office in the amount of \$147.00.

11 7.  That the defendant/respondent's owes reimbursement to  
12 plaintiff Peggy Jean Willard for pregnancy, birth, and  
13 confinement expenses in the amount of \$555.55, associated  
14 with the birth of his minor child HAROLD WESLEY ROBERT  
15 WILLARD, born March 28, 1988.

16 8.  The Court further finds that:

17 (1) The defendant has agreed by stipulation to  
18 pay \$20.00 per month toward satisfaction of his  
19 \$147.00 reimbursement owed to the Douglas County  
20 District Attorney's Office, until paid in full.  
21 Thereafter, defendant's \$20.00 monthly reimbursement  
22 payment shall be applied toward pregnancy, birth and  
23 confinement expenses in the amount of \$555.55, until  
24 paid in full. Thereafter, defendant's \$20.00  
25 monthly reimbursement payment shall be applied  
26 toward child support arrears in the amount of  
27 \$990.00 until paid in full.

28 THEREFORE, IT IS HEREBY ORDERED THAT:

1.  That the defendant/respondent is the parent of the  
2 following child/ren:

3 HAROLD WESLEY ROBERT WILLARD Born: March 28, 1988

4.  Judgment is entered in favor of the Douglas County  
5 District Attorney's Office and against defendant/  
6 respondent in the amount of \$147.00 for paternity  
7 blood testing costs.

8.  Judgment is entered in favor of plaintiff/petitioner  
9 Peggy Jean Willard and against defendant/respondent  
10 in the amount of \$555.55 for pregnancy, birth, and  
11 confinement expenses.

9.  Judgment is entered in favor of plaintiff/petitioner  
10 Peggy Jean Willard and against defendant/respondent  
11 in the amount of \$990.00 for child support arrearages.

1 5.  That defendant/respondent shall pay \$130.00 per month,  
beginning April 15, 1990, to be paid as follows:

6 6.  The defendant respondent shall obtain health insurance  
for his minor child HAROLD WESLEY ROBERT WILLARD.  
Defendant shall amend his present health benefits  
7 insurance policy to include his minor child HAROLD WESLEY  
8 ROBERT WILLARD.

9 7.  The defendant/respondent shall notify the Court of any  
change of address/employment within 10 days.

10 8.  It is further ordered that:

11 (1) Defendant's \$130.00 monthly child  
12 support obligation shall be due on the 15th day of  
13 April, 1990, and shall continue due on the  
14 15th day of each month thereafter until further  
15 order of this Court.

16 (2) That when defendant's minor child/ren  
17 emancipate/s, defendant shall continue to pay  
18 \$110.00 per month toward satisfaction of then  
19 existing child support arrears.

20 (3) That defendant's ordered \$20.00 monthly  
21 payment on child support arrearages does not  
22 preclude other methods of collection for child  
23 support arrears.

24 (4) This support order shall be reviewed every  
25 three years in accordance with NRS 125B.145.

26 (5) That defendant's monthly child  
27 support payments shall be in the form of a  
28 cashier's check, certified check, or money order,  
or in cash. If the payment is in the form of cash,  
it must be delivered to the Douglas County Clerk at  
her office in Minden, Nevada. If the payment is in  
the form of a cashier's check, certified check, or  
money order, it must be made payable to the  
DOUGLAS COUNTY CLERK, must contain the notation  
Case No. 21136 (MARIN), and be either mailed to  
the Douglas County Clerk at Post Office Box  
218, Minden, Nevada 89423, or delivered to said  
County Clerk at her office in Minden, Nevada.  
The Douglas county Clerk shall transmit all ongoing  
child support payments of \$110.00 per month to PEGGY  
JEAN WILLARD, P.O. Box 32, Genoa, Nevada, 89411.  
The Douglas County Clerk shall transmit \$20.00  
reimbursement payment per month to the Douglas  
County District Attorney's Office until \$147.00 has  
been paid in full, thereafter all ongoing and

reimbursement payments shall be transmitted to Peggy Jean Willard.

9. X NOTICE: This is an income withholding order. Support payments in arrears by 30 days may be withheld from income without further order of any court or further application for services.
