- 1 4. ✓ That \$250.00 per month is a reasonable amount of support
 2 5. ✓ That the defendant/respondent is in arrears in the
 3 amount of \$30,300.00 as of March 31, 1990.
 4 6. ✓ The Court further finds that:
 5 (1) The defendant has agreed by stipulation to
 6 pay \$25.00 per month toward satisfaction of his
 7 \$30,300.00 child support arrearage referred to in
 8 Findings No. 5.

9 THEREFORE, IT IS HEREBY ORDERED THAT:

- 10 1. ✓ That the defendant/respondent is the parent of the
 11 following child/ren:

 13 2. ✓ Judgment is entered in favor of plaintiff/petitioner
 14 BEVERLY BOHLER and against defendant/respondent in
 15 the amount of \$30,300.00 for arrearages.
 16 3. ✓ That defendant/respondent shall pay \$275.00 per month,
 17 to be paid as follows:

- 18 4. ✓ The defendant/respondent shall notify the Court of any
 19 change of address/employment within 10 days.
 20 5. ✓ It is further ordered that:
 21 (1) Defendant's first \$275.00 monthly child
 22 support obligation shall be due on April 16, 1990,
 23 and shall continue to be due on the 15th day of each
 24 month thereafter until further order of this Court.
 25 (2) That when defendant's minor
 26 child/ren emancipate/s, defendant shall
 27 continue to pay \$275.00 per month toward
 28 satisfaction of then existing child support
 arrears.
 (3) That defendant's ordered \$25.00 monthly
 payment on child support arrearages does not
 preclude other methods of collection for child
 support arrears.
 (4) This support order shall be reviewed every
 three years in accordance with NRS 125B.145.
 (5) That defendant's monthly child
 support payments shall be in the form of a
 cashier's check, certified check, or money order,

1 or in cash. If the payment is in the form of cash,
2 it must be delivered to the Douglas County Clerk at
3 her office in Minden, Nevada. If the payment is in
4 the form of a cashier's check, certified check, or
5 money order, it must be made payable to the
6 DOUGLAS COUNTY CLERK, must contain the notation
7 Case No. 23271 (BOHLER), and be either mailed to
8 the Douglas County Clerk at Post Office Box
9 218, Minden, Nevada 89423, or delivered to said
10 County Clerk at her office in Minden,
11 Nevada. The Douglas County Clerk shall
12 transmit said payments to: DISTRICT ATTORNEY,
13 Family Support Division, P.O. Box 448, Santa Ana,
14 CA 92702 (Case No. 17-05-46/2U).

6. X NOTICE: This is an income withholding order. Support
15 payments in arrears by 30 days may be withheld from income
16 without further order of any court or further application
17 for services.
