1. That the Court has jurisdiction of the parties and subject matter of this case.
2. That the defendant/respondent is the parent of the following child/ren:

1 3. That the defendant/respondent owes a duty of support to

6 4. That \$1,365.00 per month is a reasonable amount of support
7 for defendant/respondent to pay.

8 5. That the defendant/respondent is in arrears in the
9 amount of \$19,748.28 as of May 15, 1990.

10 6. The Court further finds that:

11 (1) Defendant has been credited with payments
12 made to plaintiff following this court's order re
13 contempt entered July 26, 1988.

14 THEREFORE, IT IS HEREBY ORDERED THAT:

15 1. That the defendant/respondent is the parent of the
16 following child/ren:

17 MATTHEW DAVID LINCOLN Born: May 3, 1983
18 ANNE NICOLE LINCOLN Born: July 5, 1978
19 DANA COLLETTE LINCOLN Born: September 8, 1975

20 2. Judgment is entered in favor of plaintiff/petitioner
21 JENNIFER C. LINCOLN and against defendant/respondent in
22 the amount of \$19,748.27 for arrearages through and
23 including May 15, 1990.

24 3. That defendant/respondent shall pay \$1,501.50 per
25 month, beginning June 15, 1990, to be paid as follows:

26 4. The defendant/respondent shall provide health insurance
27 obtaining payment for insured services.

28 5. The defendant respondent shall pay medical expenses,
including dental and ophthalmological services for the
child(ren) as follows:

(1) Defendant shall pay for one-half of all
unreimbursed medical expenses incurred on behalf of
his minor children.

1 6. The defendant/respondent shall notify the Court of any
change of address/employment within 10 days.

2 7. It is further ordered that:

3 (1) Defendant's \$1,501.50 monthly child
4 support obligation shall be due on the 15th day of
5 June, 1990, and shall continue due on the 15th
day of each month thereafter until further order
of this Court.

6 (2) That when defendant's minor child/ren
emancipate/s, defendant shall continue to pay
7 \$1,365.00 per month toward satisfaction of then
existing child support arrears.

8 (3) That defendant's ordered \$136.50 monthly
payment on child support arrearages does not
9 preclude other methods of collection for child
support arrears.

10 (4) This support order shall be reviewed every
three years in accordance with NRS 125B.145.

11 (5) That defendant's monthly child
12 support payments shall be in the form of a
cashier's check, certified check, or money order,
13 or in cash. If the payment is in the form of cash,
it must be delivered to the Douglas County Clerk at
14 her office in Minden, Nevada. If the payment is in
the form of a cashier's check, certified check, or
15 money order, it must be made payable to the
DOUGLAS COUNTY CLERK, must contain the notation
16 Case No. 23208 (LINCOLN), and be either mailed to
the Douglas County Clerk at Post Office Box
17 218, Minden, Nevada 89423, or delivered to said
County Clerk at her office in Minden,
18 Nevada. The Douglas County Clerk shall
transmit said payments to JENNIFER C. LINCOLN, P.O.
Box 3316, Stateline, Nevada 89449.

19 8. NOTICE: This is an income withholding order. Support
20 payments in arrears by 30 days may be withheld from income
21 without further order of any court or further application
for services.
